MONITORING AND AUDITING ICT PROJECTS

(13th – 18th August 2018 - IAA Arusha Campus, Arusha)

1.0 Course Background

Studies show that only 20% of ICT projects are completed successfully. The remaining are either delivered with partial functioning, exceed original budget and are completely abandoned. As such the intended benefits of the ICT projects are not realized and organizations incur losses and inefficiency in their key business operations. The effective and efficient monitoring and auditing of ICT projects is therefore crucial to running a successful organization that not only values its customers, but also generates return on the ICT investment. This course is aimed at covering the fundamental principles of ICT projects and provides up-to-date processes and techniques for monitoring and auditing.

2.0 Course Contents

At the end of the course, participants will be able to:

- (i) Gain knowledge of what constitute of a well-managed ICT project
- (ii) Audit the ICT project's methodology, processes and tools including contracts and procurement arrangements
- (iii) Apply audit techniques to complete the ICT project health check from beginning to end
- (iv) Analyze the risks associated with ICT projects
- (v) Analyze ICT project schedules, budgets and quality

- (ii) Business and IT strategy
- (iii) Systems Development and Acquisition
- (iv) ICT Auditing Techniques
- (v) Assessment of ICT project's design
- (vi) Technical feasibility study
- (vii) Audit and Project Management
- (viii) Pre-implementation review
- (ix) Post-implementation review
- (x) ICT Risk Assessments
- (xi) ICT Project Monitoring and Evaluation using Key Performance Indicators

4.0 Target Group

This course is intended for auditors/internal auditors, risk managers, Audit Managers, Managers of Compliance, Finance Directors and Managers, Heads of Project Financing, Procurement Officers, ICT Managers, ICT officers, Quality Assurance Managers and any employees or management team responsible for the successful execution of ICT projects.

5.0 Fees & Mode of Payment:
